I,  _____ (print name) do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with the **NSSA KEWALO**, transportation of equipment related to the activities, and traveling to and from activity sites in which I am about to engage.

Inherent hazards and risks include but are not limited to:

- 1 Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and back or other bodily injuries that may result in permanent disability and death.
- 2 Possible equipment failure and/or malfunction or misuse of my own or other's equipment.
- 3 I AGREE THT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, neck or spinal cord.
- 4 Variation and/or steepness of terrain, variation or changes in surfaces including but not limited to surf, snow surfaces, ice, bare spots, rocks, stumps, debris, padded & non-padded barriers, other persons, and other natural and man-made hazards.
- 5 My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, waves, weather, riding surfaces or other obstacles.
- 6 Exposure to the elements and temperature extremes may result if frost nip, frost bite, heat exhaustion, heat stroke, sunburn, hypothermia & dehydration.
- 7 Dangers associated with exposure to natural elements include but are not limited to avalanche, rock fall, inclement weather, thunder & lighting, severe and or varied wind, water, surf, temperature and other weather conditions.
- 8 Accidents or illness occurring in remote places where there are no available medical facilities.
- 9 Fatigue, exhaustion, chill, and or dizziness, which may diminish my reaction time and increase the risk of accident.
- 10 Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles, and cyclists.

- 2 To release the releases, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I , my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities
- 3 whether caused by active or passive negligence of the releases or otherwise. By executing this document, I agree to hold the releases harmless and indemnify them in conjunction with any injury, disability, death, or lost or damage to person or property that may occur because of my engaging in the above activities.
- 4 By entering into this Agreement, I am not relying on any oral or written representation or statements made by the releases, other than what is set forth in this Agreement.
- 5 This Agreement shall apply to all injury, disability, death, or loss or damage to person or property occurring at any time after the execution of this agreement.

This release shall be binding fully permitted by law. If any provision of this release is found to be unenforceable, the remaining terms shall be enforceable.
