## 2010 HAWAII REGIONAL CHAMPIONSHIP

### GENERAL INFORMATION

March 13-18 • Open & Explorer Championships  
March 16 • NSSA Hawaii Awards Banquet

The NSSA Hawaiian Regional Championships will be held at Kewalo Basin, Oahu, as conditions permit.

#### REGIONAL CHAMPIONSHIPS

This is the 13th Annual Hawaiian Regional Championships. The Regional Championships is a state-wide 6 star PRIME event. Selection for Nationals will be based on results from the 2009-2010 season with results from this Regional Championships event. This event will be NSSA Hawaii's premiere event and will include an awards Banquet.

#### NSSA NATIONAL CHAMPIONSHIPS QUALIFIER

The Hawaiian Regional Championships IS REQUIRED IN ORDER TO QUALIFY FOR NATIONALS. In order to qualify for Nationals, you must enter each division that you want to compete in at the Nationals. Final results in each division at this event, and your 5 highest season's events, will determine the order competitors are selected for Nationals. **If you do not compete in this Hawaiian Regionals Championships event, you can not compete in the national championships. No exceptions.**

#### ENTRY FEES

Entry fees for each division are \$80 (\$85 for surfing up a division) payable to NSSA Hawaii and include one banquet ticket. Entry fees for the Open Mini Groms are \$40 and also include one banquet ticket. Additional Banquet tickets are \$40.

Entry forms must be submitted with payment. There will be no sponsor billing for this event. Entry forms must be received by Feb. 23, 2010. If an entry is received without payment it will be held for an alternate slot. Faxed, late and/or unpaid entries will be held for alternate slots. Late entry fees are \$100 per division (\$60 mini grom) and must be paid in cash or by cashier's check only. You must send your entry in by the deadline. There will be no beach entries.

#### REPORT CARDS

All competitors who include a copy of their 1st Semester Report Card with their entry form will be entered in a prize drawing at the Awards Banquet. 3 chances will be given for each A, 2 chances for each B, and 1 chance for each C. Home schooled entrants must submit an official document on school letterhead signed by the school administrator or official. You must be present to win.

#### DIVISIONS

The contest format will be the same as Nationals with 6-person heats. The divisions that you may enter are listed on the entry form inside. The number of slots available for Nationals in each division will be announced at this event.

OPEN MEN & WOMEN WILL FEATURE **4-PERSON HEATS** FROM THE SECOND ROUND ON. (The first round will be 6-person heats because of time restraints.)
